TERMS OF CONTRACT:

this approved list will be in violation. If that happens, your trailer can be closed down for the event.

Your trailer will need to be brought to the park on Friday, August 16, and picked up either Sunday, August 18 or

Monday, August 19. (You will not be able to remove the trailer on the day of the event.)

*We will reserve spaces for <u>two vehicles</u> in the nearest parking lot. All other workers must park in the vendor

parking lot. No vehicles are allowed by the trailers in Ross Park.
