**TERMS OF CONTRACT:**

We expect you to sell only those items that are listed on this contract which are approved by us. Any changes from this approved list will be in violation. If that happens, your trailer can be closed down for the event.

Your trailer will need to be brought to the park on Friday, August 14, and picked up either Sunday, August 16 or Monday, August 17. **(You will not be able to remove the trailer on the day of the event.)**

*\*We will reserve spaces for two vehicles in the nearest parking lot. All other workers must park in the vendor parking lot. No vehicles are allowed by the trailers in Ross Park.*

***Please Note: If you want to participate in this year's show you must be completely set up no later than 9pm on Friday August 14<sup>th</sup>. If you are unable to be onsite before designated timeframe you will lose your entry and no refund will be granted.***
